# PREVENTING AND RESPONDING TO THE ABUSE, NEGLECT, EXPLOITATION, AND DISCRIMINATION OF PEOPLE WITH DISABILITY

- Promote a culture of no retribution in the case of reporting, including reporting of suspected or alleged abuse, neglect or exploitation or incidents suggestive of abuse, neglect or exploitation
- Ensure that there are systems to identify abuse, neglect or exploitation of service users including acting in accordance with the requirements of the NDIS Quality and Safeguards Framework (including the Reportable Incidents requirements), the Department of Communities, Child Safety and Disability Services' Critical Incident Policy and Child Safety Services reporting of child abuse procedures
- Take all reasonable steps to prevent and respond to all forms of violence against and exploitation, neglect and abuse of people with a disability
- Ensure timely, adequate and appropriate
  responses to incidents including the management
  of suspected or alleged violence, abuse, neglect,
  exploitation or discrimination which aligns with the
  NDIS Incident management and reportable
  incidents
- Ensure each participant is provided with information about advocates available to assist where allegations of Violence, Abuse, Neglect and discrimination have been made
- Foster best practice through ongoing systems review
- Promote an integrated, evidence-based approach to the prevention and identification of and response to abuse, neglect and exploitation, which is supported by ongoing and appropriate workforce development and training. The training includes developing understanding, creating awareness and strategies to incorporate in everyday practice
- Supports structure ensures that reasonable care is taken to avoid foreseeable risks without limiting the individual's freedom of choice.
